- Two Camera Ceremony Professional Editing
- One Camera Reception At least One VHS Edited Master Tape & One DVD with Custom Chapter Points

Contract camera time begins one hour prior to the scheduled starting time of your ceremony and is based on continuous hours on the clock.

Additional camera hours are available @ \$100.00 per hour.

Payment shall be made as follows:

A nonrefundable deposit of 50% of the total amount due is required upon signing and returning this contract. Payment may be made in cash or by personal check, money order, MasterCard, VISA or American Express. Checks should be made payable to Artistic Video Productions. If payment is made by credit card, the balance due will be charged to your account on the Friday prior to your wedding. If payment is made by cash or check, the balance due must be paid in full **on or before the date of your wedding**. There is 8.25% sales tax on the total amount of all orders.

Artistic Video Productions exercises the utmost care with respect to the video services and products offered. Any liability of Artistic Video Productions is limited to monies paid.

Raw video footage is retained by Artistic Video Productions for no longer than two (2) months following the event date. Artistic Video Productions reserves the right to use the original tape, excerpts and/or reproductions for display or promotional purposes.

Should the event be postponed or cancelled, the deposits paid are not refundable.

No DVD or videotape, either in progress or completed may be removed from the studio premises unless the balance due has been paid in full.
